



ASAN-UK Terms & Conditions

1. About ASAN-UK

ASAN-UK (American Student and Alumni Network - UK) is a membership organization for American students and alumni studying in the United Kingdom.

Legal Entity:

ASAN-UK is owned and operated by **UK College Admissions Ltd**, a company registered in England and Wales (Company No. 12138795), registered address: 17 Greenfields Way, Burley in Wharfedale, LS29 7RB, United Kingdom.

All references to "ASAN-UK," "we," "us," or "our" in these Terms refer to UK College Admissions Ltd trading as ASAN-UK.

2. Membership

2.1 Eligibility

Membership is open to American citizens and permanent residents who are currently studying or have studied at a UK university, or who are planning to study in the UK.

2.2 Free Membership

ASAN-UK membership is free. There are no membership fees.

2.3 Membership Benefits

Members receive:

- Access to ASAN-UK events and networking opportunities
- Eligibility to enter the ballot for the National American Students Conference
- ASAN-UK newsletters and communications
- Information about postgraduate study, scholarships, and career opportunities

2.4 Membership Term

Membership continues indefinitely unless you choose to cancel or your membership is terminated in accordance with these Terms.

3. National American Students Conference

3.1 Ballot System

The National American Students Conference is free to attend, but spaces are limited. ASAN-UK members may enter a ballot for places at the conference.

3.2 Selection Process

Conference places are allocated via ballot to ensure fair representation from universities across the UK. Entry into the ballot does not guarantee a place at the conference.



3.3 Referral Bonus

Members who refer friends to join ASAN-UK may receive additional ballot entries as specified during registration.

3.4 Ballot Results

Members will be notified of ballot results via email. Selected members must confirm their attendance within the specified timeframe or their place may be reallocated.

3.5 Conference Conduct

Members attending ASAN-UK events must conduct themselves appropriately and respectfully. ASAN-UK reserves the right to remove attendees who engage in disruptive, discriminatory, or dangerous behaviour.

4. Data Sharing and Privacy

4.1 Consent to Data Sharing

By joining ASAN-UK, you consent to your information being shared with partner UK universities and education-related sponsors as described in our Privacy Policy and Consent Form.

4.2 Marketing Communications

You consent to receive marketing communications from ASAN-UK and our partners. You may withdraw this consent at any time as described in our Privacy Policy.
